#### **National Initiatives**

#### United States: National Bone Health Alliance

The National Bone Health Alliance (NBHA) established a secondary fracture prevention initiative in 2011. In 2013, NBHA launched a website — Fracture Prevention CENTRAL — which provides a comprehensive suite of resources relating to implementation of FLS in the United States and is available at http://www.nbha.org/fpc.

### United Kingdom: National Osteoporosis Society

Since 2009, the National Osteoporosis Society (NOS) in the United Kingdom has led advocacy for universal access to FLS across the UK. This work has culminated with the establishment of a national Falls and Fractures Alliance (FFA). Membership of the FFA includes many leading professional organisations and patient societies in the UK. All members have signed a Falls and Fractures Declaration to describe and report on an annual basis the actions they are taking to reduce the incidence of fragility fractures.
